




FINANCIAL TRANSPARENCY

ARPA UPDATES



ver the coming months, our social media channels and website will be taking a look at federally funded ARPA projects completed by a variety of Hartland community groups.

In 2021, in an effort to help Americans respond to and recover from the effects of Covid-19, Congress passed

a bipartisan bill to allocate funds to

meet the needs of local units of government. The US
Department of Treasury oversaw the America Rescue Plan Act (ARPA),
ensuring that money was utilized to make investments in water, sewer,
and broadband infrastructure, along with other capital projects within
communities. Dispersed and managed by the State of Michigan, money
was apportioned based on population. Hartland Township received 1.5
million dollars and was granted flexibility in choosing how they would
spend the funds within the provided guidelines.

After working on a few key infrastructure projects around the township, and with resources still available, the Township Administration developed a program which provided non-profit community civic organizations the opportunity to request funding for community projects offering public benefit.

We are so proud of how this collaboration has involved and empowered groups around Hartland. And in the spirit of transparency, we are pleased to share this series of community ARPA updates. Join us as we highlight and celebrate these non-profit civic organizations and the good stewardship of funds allocated to Hartland Township. THINKING ABOUT 'DOWNSIZING'?

Understand the impacts of Proposal A on your Property Taxes

If you have reached that time of your life when you are pondering the thought of 'downsizing' your home to something smaller, perhaps something lower in maintenance with smaller expenses, there is one aspect that you should consider when taking that leap: Your property taxes.

Thanks to Proposal A of 1994, you have likely benefitted from a 'cap' on the annual increase of the taxable value of your property. This 'cap' has limited the amount that your property taxes could increase each year. However, once you purchase a new property, that 'cap' no longer applies to the new property, and the year following the purchase of property the taxable value becomes 'uncapped', and then in the years following, the 'cap' goes into place again.

So when you may have paid \$3,600 per year in taxes on your large family home on an acre of land that you owned for twenty years, your newly purchased 'downsized' 1,200 square foot attached condo may have taxes of \$5,100. This often is quite a shock to buyers when they receive their new tax bills. While discussions on the impact of Proposal A were common when it was passed in 1994, those impacts are rarely discussed between a buyer and their agent now. We hope to help inform our residents of how property taxes can change after the purchase of a property so that they can be better prepared.
